Loan of \$1.5M to National Hotels Supplies Ltd. from the Bank of Nova Scotia Ja. Ltd.

The House of Representatives is asked to note that the Bank of Nova Scotia has agreed to make a loan of \$1.5M available to National Hotel Supplies.

National Hotel Supplies is a wholly owned subsidiary of
National Hotel and Properties Ltd. which is a wholly owned subsidiary
company of Urban Development Corporation. National Hotels Supplies Ltd.
started operations in January 1978, supplies foods, beverages, operating
equipment and miscellaneous items to all hotels and other tourist related
businesses in Jamaica including those hotels owned and/or operated by
National Hotel and Properties.

The original loan of \$1.5M was used to cover the shortfall experienced during the 1978 Winter Tourist Season and was negotiated with Jamaica Citizens Bank on the 1st December 1978, the loan was then taken over by the Bank of Nova Scotia on the 19th July 1979. The captioned loan was due for repayment on the 31st October 1980, however National Hotels and Properties Ltd were not in a position to repay due to the need to expand large sums to establish letters of Credit needed for the purchase of supplies for the 1980 Winter Tourist Season, the loan is scheduled to be repaid by June 30, 1982.

The Ministry of Finance gave its irrevocable and unconditional undertaking to provide Government guarantee for the abovementioned loan.

Amoritization:- The principal is repayble by June 30, 1982

Interest:Prime plus one percent (presently 13%)

Security:- Formal guarantee of the Government of Jamaica.

The House of Representatives is asked to approve the guarantee of the repayment of the interest and the repayment of the principal on the subject loan, under the provision of the approved Organisations and Authorities Loans Act.
