LOAN OF US\$6,000,000.00 FROM CARIBBEAN DEVELOPMENT BANK TO THE NATIONAL DEVELOPMENT BANK

The House of Representative is asked to note that the Caribbean Development Bank has made a loan of US\$6,000,000.00 available to the National Development Bank.

The purpose of the loan is to provide the financing of Industrial Development and for Medium and Long Term Sub-Loans to persons and Enterprises, for Industrial purpose.

The terms and conditions of the abovementioned loan between the Caribbean Development Bank and National Development Bank are set out hereunder:-

AMOUNT: US\$6,000,000.00

REPAYMENT: The loan is to be repaid in forty-eight (48) equal and consecutive quarterly instalments. The first instalment is due three (3) years from the date of the first disbursement of the loan.

INTEREST: At the rate of Nine and a Half percent (91%)

per annum on the amount withdrawn and out
standing.

COMMISSION: The National Development Bank will pay the Caribbean Development Bank a commission of One percent (1%) per annum of the amount of the loan withdrawn.

COMMITMENT
FEE: The National Development Bank will also pay
the Caribbean Development Bank a Commitment
Fee of One percent (1%) on the amount of the
loan unwithdrawn.

SECURITY: Alformal Guaranteeissued by the Government of Jamaica of the Approved Organization and Authorities loan Act.

The House of Representative is asked to approve the Guarantee of the repayment of principal and the payment of interest on the subject loan of US\$6,000,000.00 from Caribbean Development Bank to the National Development Bank.
