

THE HON. ANTHONY MUSGRAVE, of Port Moresby, British New Guinea, *b.* 28th April, 1849. He was private secretary to Sir Anthony Musgrave in Newfoundland, 1868-9, in British Columbia, 1869-72; private secretary and clerk of Executive Council, Natal, 1872-73; in South Australia 1873 to 1877; private secretary in Jamaica, 1877-83, and in Queensland 1883-85; assistant deputy commissioner in British New Guinea, 1885, government secretary and member of the Executive and Legislative Councils, 1888, and local auditor, November, 1890.

Lineage.

WILLIAM MUSGRAVE sailed from Bristol, England, and settled in Montserrat. He was appointed member of the council of Nevis and Montserrat in 1750, and was afterwards president of the latter and assistant judge of the King's Bench in 1788. He *m.* Sarah, daughter and co-heiress of Anthony LYNCH, son of Nicholas LYNCH, of Galway, and *d.* 1783 (will dated 29th July, 1780), leaving issue,

ANTHONY MUSGRAVE, M.D. (Edinburgh), treasurer of Antigua, West Indies 1825-1852, *b.* 20th October, 1793; *m.* 18th May, 1820, Mary Harris, daughter of Samuel SHERIFF, of the same island, and *d.* in Antigua, 24th February, 1852, having by her (who was *b.* 24th June, 1801, and *d.* in London, August, 1856) had issue,

Anthony (Sir), G.C.M.G., *b.* 31st August, 1828, was appointed Colonial Secretary of the Island of Antigua, in February, 1854, administrator of the Island of Nevis, October, 1860, and of St. Vincent, April, 1861, Lieutenant-Governor of St. Vincent, May, 1862, Governor of Newfoundland, April, 1864, and of British Columbia, June, 1869; Lieutenant-Governor of Natal, May, 1872; Governor of South Australia, June, 1873, of Jamaica, January, 1877, and lastly, of Queensland in November, 1883, in which office he died. Sir Anthony, who was created C.M.G. in 1871, K.C.M.G. 1875, and G.C.M.G. 1885, *m.* first, 1854, Christiana Elizabeth, youngest daughter of the Hon. Sir William BYAM, of Cedar Hill, Antigua, and Westwood, Hants, England, and by her, who *d.* 1859, had issue,
