### THE DISASTER RISK MANAGEMENT ACT

THE DISASTER RISK MANAGEMENT (ENFORCEMENT MEASURES) (NO. 14) (AMENDMENT) ORDER, 2020

WHEREAS the Minister responsible for disaster preparedness and emergency management has given written notice to the Prime Minister that Jamaica appears to be threatened with or affected by the SARS–CoV-2 (Coronavirus COVID-19), and that measures apart from or in addition to those specifically provided for in the Disaster Risk Management Act should be taken promptly:

AND WHEREAS on March 13, 2020, the Prime Minister by Order declared the whole of Jamaica to be a disaster area:

NOW THEREFORE:

In exercise of the powers conferred upon the Prime Minister by section 26(2) of the Disaster Risk Management Act, and every other power hereunto enabling, the following Order is hereby made:—

1. This Order may be cited as the Disaster Risk Management (Enforcement Measures) (No. 14) (Amendment) Order, 2020, and shall be read and construed as one with the Disaster

Risk Management (Enforcement Measures) (No. 14) Order, 2020, hereinafter referred to as the principal Order, and shall take effect on the 14th day of October, 2020.

2. Paragraph 5(6) of the principal Order is amended by inserting next after the words "described in the Second Schedule" the words "or that is listed in the Appendix to Form C of the First Schedule".

- 3. Paragraph 25 of the principal Order is amended—
  - (a) in sub-paragraph (2), by deleting the words "a specified area" and substituting therefor the words "the Whitfield Town Curfew Area and the Waterford Curfew Area, described in the Seventh Schedule";
  - (b) in sub-paragraph (3), by deleting the words "a specified area" and substituting therefor the words "the Whitfield Town Curfew Area, and the Waterford Curfew Area, described in the Seventh Schedule";
  - (c) by inserting next after sub-paragraph (3) the following sub-paragraph—

" (4) In respect of the Rae Town Curfew Area and the Cornwall Courts Curfew Area, described in the Seventh Schedule, the requirement under paragraph 10 to remain at an abode or place of residence shall be read and construed as applying during the period from October 23, 2020, to November 6, 2020, during the hours from 6:00 pm to 5:00 am each day, beginning at 6:00 pm on October 23, 2020, and ending at 5:00 am on November 6, 2020.".

- 4. The First Schedule to the principal Order is amended-
  - (a) in Form C, by inserting next after the words—

"

- (i) "<u>remain in the hotel property or properties stated below within the</u> <u>COVID19 Tourism Resilient Corridor</u>" the words "<u>or listed in the</u> <u>Appendix hereto</u>";
- (ii) "that is certified by the Jamaica Tourist Board to be a COVID-19 Resilient licensed attraction located within the area of any part of the Resilient Corridor" the words "or that is listed in the Appendix hereto"; and
- (b) by inserting next after Form C the following as the Appendix thereto—

5. The Seventh Schedule to the principal Order is amended by inserting next after the description of the Waterford Curfew Area the following descriptions—

"RAE TOWN CURFEW AREA—The area of interest spans approximately 2.4 sq. km and is bounded by a 2.43 km perimeter.

The boundary will start at the four (4) way intersection with Upper Elletson Road, Lower Elletson Road, Victoria Avenue and Windward Road and run along Windward Road for approximately 0.37 km to the intersection with Paradise Street.

The boundary will continue in a southerly direction for approximately 0.56 km along Paradise Road, to the intersection with Michael Manley Boulevard; and continue farther south-easterly for approximately 0.17 km along an imaginary line which crosses the major gully way south of Michael Manley Boulevard, to a point along the Kingston Harbour shoreline.

The boundary will continue westerly along the Kingston Harbour shoreline for 0.61 km to a western point along Kingston Harbour shoreline that is immediately adjacent to the Michael Manley Boulevard.

The boundary will continue north for 0.2 km along an imaginary line from the western point along the Kingston Harbour shoreline (that is immediately adjacent to the Michael Manley Boulevard) to the intersection of Lower Elletson Road and Rae Street; continue in a northerly direction along Lower Elletson Road for approximately 1.53 km; then terminate at the starting point at the four (4) way intersection with Upper Elletson Road, Lower Elletson Road, Victoria Avenue and Windward Road.

## CORNWALL COURTS CURFEW AREA

Inclusive of the main entrances to Cornwall Courts from Green Pond (Ramtallie Boulevard) and Porto Bello Estate (Cornwall Court Boulevard) as well as informal entry/exit point from Ramtallie Boulevard to the School Zone and Green Pond Grove HS/Porto Bello Estate.".
